

NOTICE TO BIDDERS

Notice is hereby given that the Board of Trustees of the Buckeye Union School District, referred to as the Owner, will receive sealed proposals for the furnishing of all labor, materials, transportation, equipment and services necessary for construction of the Camerado Springs Middle School, Multi-purpose and Library Additions in Cameron Park, California. Bids will be received at the School District Offices at 4560 Buckeye Road, Shingle Springs, California, until **2:00 pm, local time, on Tuesday, March 9, 2004**, at which time they will be publicly opened and publicly read.

The project consists of a 984 SF Addition to the existing Library Building and a 600 SF Kitchen Addition to the existing Multi-purpose Building, plus miscellaneous site work (sidewalk additions and modifications, parking striping and signage modifications, and storm drain system additions) as shown on the Construction Documents prepared by the Architect, Murray & Downs AIA - Architects, Inc., 3025 Sacramento Street, Placerville, CA 95667, (530) 626 1810. A mandatory pre-bid walk-through will be held at 3 PM. on Thursday, February 12, 2004 at 2480 Merrychase Drive, Cameron Park, CA.

Bids will be stipulated sum type. No bid will be considered unless it is made on the form provided by the Architect and accompanied by Money Order or Bidder's Bond from a surety company registered with the State of California Insurance Commissioner, for 10% of the amount of the bid, made payable to the Owner. Such money order or bid bond shall be given as a guarantee that the bidder will execute the Contract, if it be awarded to him, in conformity with the Contract Documents.

Bid shall not expire for a period of ninety (90) days after the scheduled closing time set for receipt of bids. The Contractor awarded the project will be required to provide 100% Payment Bond and 100% Performance Bond. Contractor shall possess a valid Class B General Building Contractor license issued by the California Contractors State License Board.

Copies of the prevailing rate of per diem wages are on file and open to public inspection at the office of the Owner, and reference is made specifically thereto. Attention is directed to the provisions of Section 1777.5 and 1777.6 of the Labor Code of the State of California concerning employment of apprentices by the contractor or any subcontractor under him.
