

## NOTICE TO BIDDERS

Notice is hereby given that the Rescue Union School District, referred to as the Owner, will receive sealed proposals for the furnishing of all labor, materials, transportation, equipment and services necessary for construction of the New Kindergarten Building and Modernization of an Administration Building and Library/Classroom Building at Rescue Elementary School in Rescue, California. Bids will be received at the School District Offices at 2390 Bass Lake Road, Rescue, California, **until 2:00 pm on Tuesday, March 13, 2007** at which time they will be publicly opened and publicly read.

**Increment 1-New Kindergarten Building (N.I.C.). Increment 2-Modernization** consists of 8,470 square feet of modernization to existing Buildings C & D and 10 acres to sitework. **Increment 1 (which is N.I.C.) and Increment 2** are shown on the Construction Documents prepared by the Architect, Murray & Downs AIA - Architects, Inc., 3025 Sacramento Street, Placerville, CA 95667, (530) 626-1810. A mandatory pre-bid walk-through will be held at **3:30 PM. on Monday, February 26, 2007** at Rescue Elementary School, 3880 Green Valley Road, Rescue, CA.

Bids will be stipulated sum type. No bid will be considered unless it is made on the form provided by the Architect and accompanied by Money Order or Bidder's Bond from a surety company registered with the State of California Insurance Commissioner, for 10 percent of the amount of the bid, made payable to the Owner. Such money order or bid bond shall be given as a guarantee that the bidder will execute the Contract, if it be awarded to him, in conformity with the Contract Documents.

Bid shall not expire for a period of thirty (30) days after the scheduled closing time set for receipt of bids. The Contractor awarded the project will be required to provide 100% Payment Bond and 100% Performance Bond. Contractor shall possess a valid Class B General Building Contractor license issued by the California Contractors State License Board.
